  - Providing expertise in recommending competitive positioning among industry peers of all investment products (internal and third-party);
  - Providing investment oversight for International Asset Management for their international/offshore mutual funds, including performance monitoring, portfolio advisor due diligence and reporting as needed;
  - Providing support for the asset allocation team, sales, marketing, and product managers on the various Investment Programs.
- Lead ongoing development and delivery of detailed investment analyses and insight, as well as accurate and timely performance reporting, for both internal and external audiences, collaborating with product, marketing and communications teams to provide key insights from oversight activities:
  - Conduct regular performance and analysis from both a compliance-to-mandate and product integrity perspective, resulting in reporting for regulatory bodies, Boards, IRC, Investment Committee and select client-facing needs;
  - Quarterly Performance Analyses.
- Manage all sub advisors relationships including contract negotiation, service level commitments, fee discrepancy resolutions, and reporting needs.
