Qualifications for this role include:

- Graduation with a diploma or a degree in resource or forestry management.
- Registered with Forest Professionals British Columbia (FPBC) as a Registered Forest Technologist (RFT) or Registered Professional Forester (RPF) AND a minimum of two (2) years of experience in operational field forestry activities, OR
- Enrolled, or eligible for immediate enrollment, with Forest Professionals British Columbia (FPBC) as a forest professional in training (TFT, ASTFT, FIT, ASFIT), for the purpose of obtaining an RFT or RPF designation AND a minimum of four (4) years of experience in operational field forestry activities.

Operational field forestry activities include one (1) or more of the following: timber harvesting, cut-block development, forest road engineering, silviculture, harvest operations or compliance and enforcement

- Must possess at minimum a valid Class 5 BC Driver's Licence that does not limit or restrict the ability to conduct the duties of the job.
