The Ministry is responsible for wildfire management and facilitates safe public access to a wide range of recreational activities such as hunting, fishing, and access to BC's wilderness and backcountry.

Qualifications for this role include:

• Registered Professional Forester (RPF), or immediately eligible for registration as an RPF, with the Association of BC Forest Professionals (ABCFP). Note: Immediately eligible is defined as being currently registered as a fully licensed professional in good standing in an applicable jurisdiction and can immediately transfer to the ABCFP as an RPF.

Applicants who do not meet the professional requirement may be considered at a lower classification, subject to confirmation of eligibility for registration as a Forester-in-Training with the ABCFP immediately upon employment with the Ministry and can attain RPF status within two years of employment. If applicable, applicants must contact the ABCFP to confirm their eligibility.

• Valid BC driver's licence that does not restrict the applicant from performing the duties of the job (Class 5, 7N, etc.).
