#### Responsibilities

As an Intake Legal Assistant, your duties will include:

- To provide legal secretarial and administrative support to staff lawyer(s) and paralegal(s).

This will include performing intake services through the Call Centre, at Main Street Court house and lock-up, Robson Square Provincial Court, Youth Court lock-up, Downtown Community Centre and other offsite locations.

You have post-secondary education in Law, Criminology, Sociology or related discipline supplemented by a minimum of two (2) years' relevant experience. You have a strong desire to assist disadvantaged clients, including those experiencing family violence or addiction issues, those with low income, those with mental disabilities, or those whose first language is not English.
