- Professional accounting designation CPA - CA, CGA, CMA, issued by a Canadian Accounting Association*.
- Minimum of 2 years audit and/or accounting experience.
- Must possess and maintain a valid Class 5, BC driver's license or equivalent, with no L restrictions.
- Preference may be given to applicants with audit experience in a consumption taxes environment.
