  - Develop and maintain strong relationships with the business partners/stakeholders and working collaboratively in a team environment with colleagues and senior client leadership
  - Meets regularly with Field Services staff to ensure appropriate action is taken in compliance with safety policies to correct or prevent hazardous conditions which may result in accidents, injuries or workers' compensation claims;
