Job Summary

- Conduct highly sensitive, complex research/analysis by identifying, collecting and assessing relevant Service information/material which may be used in policy development, operational compliance reporting, litigation, external review, and/or complaint cases.
- Develop expertise in areas including Service policy and compliance, the disclosure of Service information as it relates to civil, criminal and/or administrative litigation and ensure the protection of sensitive information through the national security provisions of s.38 of the Canada Evidence Act (CEA), s.87 of the Immigration and Refugee Protection Act (IRPA) and/or s.18.1 of the CSIS Act.
- Develop and maintain effective communication and cooperation with internal key partners, including operational divisions, Legal Services, policy centers, regional offices, and external bodies (including, but not limited to the Department of Justice (DoJ), the Canada Border Services Agency (CBSA), the Royal Canadian Mounted Police (RCMP) and Immigration, Refugees and Citizenship Canada (IRCC), National Security and Intelligence Review Agency (NSIRA), National Security and Intelligence Committee of Parliamentarians in judicial or quasi judicial proceedings.
- Maintain a constant, broad awareness of current and developing legal and/or policy issues that could impact CSIS.
- Provide comprehensive advice and recommendations to management and other branches on

complex cases and sensitive issues, such as: operational policy and compliance, litigation, reputational risk, disclosure risks, injury to the Service and to Service investigations.

- Advise, guide and act as a mentor to new analysts.
- Assist in the preparation of witnesses for litigation, quasi-judicial hearings, and/or external review bodies briefings.
- Administer various information sharing arrangements (e.g. CSIS/CBSA Share to Protect (StP), CSIS/RCMP One Vision (OV), CSIS-CCE Framework for Cooperation) which includes providing disclosure advice, drafting advisory or disclosure letters and preparing Record of Decisions (RoDs).
- Promote a healthy workplace by fostering a respectful work environment free from harassment, discrimination, racism, bullying and reprisal. Adhere to the mandatory on-line training on creating a respectful workplace.
