The Institute delivers its ethics research and consultation services worldwide to support researchers, funders, sponsors, policymakers, and other stakeholders in global health navigate through ethical issues that impact work across the innovation lifecycle. IEPI is currently supported by a major grant from the Bill & Melinda Gates Foundation (BMGF) and is responsible for delivering an ethics program of research and consultation service that supports the Foundation's Global Health division. The Assistant Director will play a primary role in monitoring the execution of the research programs key strategic outputs and making instinctive adjustments to ensure alignment with the Institute's goals and objectives. This will include reviewing the day-to-day progress of research projects, and realigning plans and resources to ensure key project deliverables are met.
