| What you'll do Responsibilities of the senior payment analyst will include:

- Provide subject matter expertise to internal and external stakeholders for any matters related to Payments Canada retail payment operations, rules, and standards;
- Manage the work related to the assigned Payments Canada task forces, committees, and working groups, including agenda management and acting as Chair or Secretary;
- Maintain a strong understanding of Payments Canada's by-laws, rules and standards as

well as industry trends to ensure operational excellence;

- Lead project teams to support the coordination and execution of operational projects and annual initiatives;
- Provide mentorship to Retail Payment Systems Analysts and assist in their development of reports for key stakeholders and senior management;
- Provide on-call support as needed to support 5x24 operations and ensure timely and accurate follow-up and reporting of all participant and Payments Canada system incidents.

| Minimum Qualifications

- Minimum of four (4) to seven (7) years of experience in a business administration, economics, policy, or finance related position;
- Experience in establishing and maintaining effective relationships with internal and external stakeholders;
