These resource initiatives are important to advance reconciliation with Indigenous peoples and sustain important ecosystems and processes. Through exploration of innovative and strategic approaches to managing natural resources, that uses socio-economic analyses as well as assessment and monitoring of the condition of natural resource values, the province can provide direction for forestry, energy development, ecosystem protection, recreation activities and other resource use decisions.
