With a comprehensive understanding of the impacts of violence and trauma on victims of crime, Victim Court Support Caseworkers provide emotional support, safety planning, referrals, information and accompaniment to victims and witnesses of serious offences and their families as they proceed through the court process. Caseworkers work independently at different courthouses without direct on-site supervision. The Caseworker should have an understanding of the Criminal Justice System and the relevant Legislation and Policy, Caseworkers interpret and convey complex case specific information to a diverse group of victims in terms they can understand.
