- Mentoring, training and directing Canada Gas Operations personnel to ensure environmental compliance, and provide field-friendly environmental support for onsite Operations staff
- Manage or support annual regional environmental activities as required
- Develop, track and forecast regional environmental budget
- Collaborate with internal environmental peers to align regional environmental work with corporate, Canada Gas Operations, Engineering and Projects and regional goals and objectives
- Collaborate with internal and external stakeholders (field operations, corporate and regulators) to identify and mitigate/manage environmental risks
- Inspect facilities to ensure environmental compliance to company and regulatory standards and procedures
- Active participation in Joint Health Safety and Environment Committee (JHSEC) and the regional Emergency Preparedness Team (EPT)
- Complete external reporting as required (air emissions, soil quality, etc); Participate in incident investigations
