The Maples Adolescent Treatment Centre is a designated provincial mental health facility providing residential, non-residential, and outreach specialized assessment and treatment services to children and youth aged 12 to 17 who experience significant psychiatric and behavioral challenges. Reporting to the Executive Director, the position is accountable for planning, development and delivery of services at the Maples Adolescent Treatment Centre, including the complex care program, and for achieving desired business results which address the needs of children, youth and families. As Director of a Mental Health facility under the Mental Health Act, the position is designated to admit, discharge, sign Consent for Treatment forms, and ensure adherence to all elements of the Mental Health Act. As the Director for purposes of committals arising under the Criminal Code of Canada, the position is responsible to the Review Board of British Columbia for detention, treatment and supervision of children and youth found unfit to stand trial or not criminally responsible because of a mental disorder.

Qualifications for this role include:

• Minimum Bachelor's degree, or preferably Master's degree in Clinical Psychology, Counselling Psychology, or Social Work. A university degree in corporate services (i.e., business administration, public administration, finance, commerce, human resources, etc.) or other related university degree or equivalent may be considered for this position.

NOTE: If your degree was obtained outside of Canada, you need to confirm it has been assessed for equivalency through the International Credential Evaluation Services (ICES). Confirmation for equivalency for your degree is required for you to be considered.

• Substantial progressive experience in leading the delivery of mental health treatment services to children and youth, preferably in a residential or hospital setting.

Extensive progressive experience may include:

• Experience of overseeing the design and delivery of operations support services.
