- Ensures wayside signal assets are properly commissioned and documented;
- Leads the investigation of Wayside signal issues;
- Provides support for training development;

- Prepares and supports detailed cost estimates and conceptual designs for the wayside signal Train Control projects including Positive Train Control;
- Develops system requirements and technical specifications for S&C use;
- Ensures/supports all wayside signal and switch equipment required for S&C projects are ordered and all required circuit drawings are produced;
- Supports Commissioning Test Plans for all S&C Projects and installations;
- Provides guidance to the S&C Construction Supervisors;
- Monitors the labour and material expenditures and ensures the charges are properly distributed and within budgetary guidelines;
- Develops and manages the Wayside Interface Unit (WIU) application software;

- Supports, prepares and reviews the procedures for the S&C Design Requirements Manual;
- Supports, prepares and adheres to all S&C Quality Plan requirements.
