You will also provide environmental expertise to various stakeholders including internal TC Energy groups as well as government staff and industry peers.

- Prepare government mandated air and GHG compliance reporting of emission sources, permit applications and emissions inventories; recommend control technology equipment and processes to ensure compliance with applicable regulations and evaluate potential for risk
