### Description

The Forest Technologist acts with specialized knowledge and training regarding the practice of professional forestry when performing a wide variety of functions including planning, engineering, timber sales and silviculture activities.

Qualifications for this role include:

• Graduation with a diploma or degree in resource or forestry management.

• Registered with the Association of British Columbia Forest Professionals (ABC FP) as a Registered Forest Technologist (RFT) or a Registered Professional Forester (RPF) AND a minimum of two years of experience in operational field forestry activities.

OR

• Enrolled, or eligible for immediate enrollment, with the Association of British Columbia Forest Professionals (ABC FP) as a forest professional in training (TFT, ASTFT, FIT, ASFIT), for the purpose of obtaining an RFT or RPF designation AND a minimum of four years of experience in operational field forestry activities

• Operational field forestry activities include one or more of the following:

- o Timber harvesting cut-block development.
- o Forest road engineering.
- o Silviculture.
- o Harvest operations.
- o Compliance and enforcement.

• Must possess at minimum a valid Class 5 B.C. Driver's License that does not limit or restrict the ability to conduct the duties of the job.
