- Updates; change customer cutoffs; create detour profiles; add and cancel trains in Nexus;
- Responsible for the export of Operating Plan changes to downstream systems via the Railway Extract & Distribution (RED) process throughout each week;
- Perform blocking plan reviews;
- Build communication broadcast describing Operating Plan changes;
- Build and maintain Local Operating Plan documents;
- Provide effective, timely support for Design systems to the Service Design department;
- Manage and input Service Design reports which include but not limited to all services SD provides through Operating Plan Explorer in CP Station;
- Provides cross functional coverage for schedule development through the use of the Intelligent Train Scheduler (ITS) application;
