 - Develop project estimate basis leveraging expertise in the particular area
 - Work with Product and resource owners to identify internal and external stakeholders, and then lead stakeholders management activities throughout the project life cycle
 - Own the development and review of project requirements with Product Owners, Solution Architects, and Technical Leads to ensure project will deliver to the planned benefits
 - Facilitate interactions between Technical Leads, Project Delivery Staff, and QA Leads to ensure that project delivery and testing completion are aligned
 - Facilitate cross-departmental project delivery activities, and gain commitment for delivery while managing competing demands, to ensure that project delivery dates are not compromised

- Plan project implementations, facilitate implementation dry runs, and lead Go live activities to ensure production implementations do not adversely impact the production environment
- Escalate material issues and risks to leadership in a timely fashion
- Ensure that Organizational Change Management activities are completed to drive product adoption
