- Apply a variety of techniques to elicit and gather business and user requirements from stakeholders;
- Understand business issues and opportunities. Analyze and define both the "As Is" and "To Be" business processes and perform gap analysis;
- Coordinate diverse groups who contribute to business requirements and build consensus for requirements across the various user groups;
- Identify assumptions, constraints, and anticipate and manage risks;
- Perform requirements analysis and develop prototype solutions to demonstrate SAP capabilities to the business and enable adoption;
- Develop functional specifications and perform functional configuration (SPRO);
- Perform data analysis to understand how data impacts solutions;
- Participate in the development and maintenance of custom built functionality and interfaces for SAP Applications and work with developers in this area;
- Participate in daily production checks and operations process required for ensuring any incidents are avoided or detected in time on SAP applications;
- Participate in an on call rotation to support 24x7 operations;
- Lead troubleshooting of incidents or defects that arise in SAP applications and ensure a timely resolution;
- Ensure that all stakeholders are updated on progress as well;

- Develop diagrams and models (use case, activity diagram, business process models, etc.) and clearly document functional requirements and business rules to describe what the system, process, or product/service must do in order to fulfill the business and user requirements;

- Complete application service requests, provide continual business application support, research transactional issues, identify root causes as well as assist with upgrade and maintenance of applications;
