The Program is also responsible for implementing policies and procedures to minimize risk, ensure accuracy while enhancing forest sector competitiveness.

The Pricing Business Analysis Forester ensures that the revenue requirements identified in the legislation, regulations, Ministry Service Plan, policy and procedures are met. This role works to explore the revenue implications of program activities, analyzes data to identify trends and initiates business improvements that streamline processes and improves certainty that correct revenues are being received from the harvest of forest resources.
