As an Economic Analyst, you will be part of the Research unit supporting the Office of the Seniors Advocate through the development and delivery of research studies, statistical and economic analyses, and interpretation of data. You will be a core member of the team, providing quantitative expertise to a variety of projects, including ad-hoc requests.
