The Inspector of Mines - Occupational Health reviews, develops, enforces, promotes and educates on occupational health regulations. These regulations are set by the Mines Act and Health, Safety and Reclamation Code for Mines in BC (HSR Code). The role may travel to do mine inspections, including reviewing health programs, training, equipment, and procedures to ensure compliance. The role will also support and guide Ministry staff and others across the province on occupational health. Additionally, the role will prepare inspection reports, guidance materials, briefing notes, and correspondence.

The BC Public Service is committed to creating a diverse workplace to represent the population we serve and to better meet the needs of our citizens. Consider joining our team and being part of an innovative, inclusive and rewarding workplace.

Qualifications for this role include:

- Master's Degree in Occupational Hygiene and a minimum of one (1) year of experience in the application of occupational hygiene principles; OR,
- A professional designation in occupational hygiene (e.g. Certified Industrial Hygienist or Registered Occupational Hygienist) and a minimum of one (1) year of experience in the application of occupational hygiene principles; OR,
- An equivalent combination of education and experience may be considered, such as a Bachelor's of Science Degree and three (3) years of application of occupational hygiene principles.

Preference may be given to candidates with one (1) or more of the following:

- Master's Degree or professional designation (e.g. CIH, ROH).
- Experience in the application of occupational hygiene principles in mining or heavy industry.
- Experience working within a regulatory agency, preferably in mining.
