Mandatory

- You must have graduated from a college or university, with a degree, diploma or post-graduate

certificate, within the past 5 years.

- You must be an Indigenous person (i.e. First Nations, Metis, Inuit).
- The position requires the successful candidate to have a valid G2 licence or above. The offer of employment is conditional upon the successful candidate providing proof that they have a valid driver's licence upon being hired.
