The Climate Change and Integrated Planning Branch (CCIPB) in the Ministry of Forests, Lands, Natural Resource Operations and Rural Development is accountable for strategic leadership of the ministry's climate change mitigation and adaptation initiatives. The branch provides climate science, policy, and analysis to support implementation of the ministry's action plan; oversees the Forest Carbon Initiative (FCI); and leads the ministry's Integrated Investment Planning process.

The Technical Advisor, Climate Change is the Ministry's representative for inter-ministry and inter-agency climate change adaptation initiatives and issues, providing professional expertise on natural resource management as related to climate change. This position is the technical authority in the adaptation field within the ministry, and oversees Ministry-specific climate change policy, research and projects, develops and supports implementation of provincial adaptation strategies, scientifically based standards, and policy positions to ensure legislation and policy reflects provincial, national and international climate change goals and obligations.

Working for BC Public Service offers a competitive salary, diverse work environment, a healthy work/life balance, and excellent benefits. In addition to the base salary for Professional Employee Association members, there is an allowance to cover professional fees, strong dental and medical plans and much more.
