The Ministry's Commercial Vehicle Safety and Enforcement Branch (CVSE) programs provide enforcement of six acts and regulations designed to improve vehicle and driver fitness and to protect the highway infrastructure.

The Commercial Transport Enforcement Officer (CTEO) enforces compliance with the acts, regulations and standards that govern the road transportation industry. The CTEO protects highway infrastructure and the safety of highway users. This position monitors roadways within an assigned area and may operate from Vehicle Inspection Stations or from an emergency equipped vehicle. The CTEO conducts safety inspections on commercial vehicles and drivers.
