As the Practices Forester, you will be accountable for performing a wide variety of professional services including operational planning, cut block and forest road layout and development, planning, and evaluating silviculture activities, and ensuring compliance with the Forest Stewardship Plan. The range of duties assigned to a particular Practices Forester will vary from business area to business area due to the geographic location, apportionment, and management requirements.

Qualifications for this role include:

• A Registered Professional Forester (RPF) or be eligible for registration as an RPF with the Association of BC Forest Professionals (ABC FP) and two years of experience in operational field forestry activities.

- o Cut-block development
- o Forest road engineering
- o Silviculture
- o Timber tenure development and administration
- o Planning integrated resource management

• Must possess at minimum a valid Class 5 B.C. Driver's License that does not limit or restrict the ability to conduct the duties of the job.
